Integrated Pest Management

Topaz<sup>®</sup> Fungicide should be integrated into an overall disease and pest management strategy (IPM) whenever the use of a fungicide is required. Cultural practices known to reduce disease development should be followed. Consult your local agricultural authorities for additional IPM strategies established for your area. Topaz<sup>®</sup> Fungicide may be used in State Agricultural Extension advisory (disease forecasting) programs which recommend application timing based on environmental factors favorable for disease development.

## **RESISTANCE MANAGEMENT**

#### GROUP 3 FUNGICIDE

Topaz<sup>®</sup> Fungicide is in the Group 3 class fungicides. Topaz<sup>®</sup> Fungicide acts as a demethylation inhibitor of sterol biosynthesis (DMI) which disrupts membrane synthesis by blocking demethylation.

Because resistance development cannot be predicted, the use of this product should follow appropriate resistance-management strategies. To delay fungicide resistance, use should be based on an IPM program that includes the following steps:

- Rotate the use of Topaz<sup>®</sup> Fungicide or other Group 3 fungicides within a growing season sequence with different groups that control the same pathogens. Avoid application of more than 3 and consecutive sprays of Topaz<sup>®</sup> Fungicide or other fungicides in the same group in a season.
- Use tank mixtures with fungicide from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum
  application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses historical information related to pesticide use, and crop
  rotation, and which considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural,

## SPRAY EQUIPMENT

Thorough coverage is necessary to provide good disease control.

To avoid spray drift, do not apply when conditions favor drift beyond the target area. Avoid spray overlap, as crop injury may occur.

Air assisted or air blast sprayers move spray droplets into the canopy using a forced air stream. Set up the fan to deliver only enough air volume to penetrate the canopy and provide good coverage. Adjust deflectors or other aiming devices to direct spray only to the target area.

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate sprayer before use.

Use a pump with capacity to: (1) maintain 35-40 psi at nozzles, and (2) provide sufficient agitation in tank to keep mixture in suspension - this requires recirculation of 10% of tank volume per minute. Use a jet agitator or liquid sparge tube for agitation. Do not air sparge.

Although Topaz<sup>®</sup> Fungicide is an emulsifiable concentrate, it is suggested that screens be used to protect the pump and to prevent nozzles from clogging. Screens placed on suction side of pump should be 16-mesh or coarser. Do not place a screen in the recirculation line. Use 50-mesh or coarser screens between the pump and boom, and where required, at the nozzles. Check nozzle manufacturer's recommendations.

For more information on spray equipment and calibration, consult sprayer manufacturers and state recommendations. For specific local directions and spray schedules, consult the current state agricultural recommendations.

## MIXING INSTRUCTIONS

Prepare no more spray mixture than is required for the immediate operation. Thoroughly clean spray equipment before using this product. Agitate the spray solution before and during application. Rinse spray tank thoroughly with clean water after each day's use and dispose of pesticide rinsate by application to an already treated area.

Topa2® Fungicide Alone: Add ½ - ½ of the required amount of water to the spray or mixing tank. With the agitator running, add the Topa2® Fungicide to the tank. Continue agitation while adding the remainder of the water. Begin application of the spray solution after the Topa2® Fungicide has completely dispersed into the mix water. Maintain agitation until all of the mixture has been sprayed.

Topaz<sup>®</sup> Fungicide + Tank Mixtures: Topaz<sup>®</sup> Fungicide is usually compatible with all tank mix partners listed on this label. To determine the physical compatibility of Topaz<sup>®</sup> Fungicide with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to 1 qt. of water. Add wettable powders and water dispersible granular products first, then liquid flowables, and emulsifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

Add ½ - ½ of the required amount of water to the spray or mixing tank. With the agitator running, add the tank mix partner into the tank. Allow the material to completely dissolve and disperse into the mix water. Continue agitation while adding the remainder of the water and the Topaz® Fungicide to the spray tank. Allow the Dagaz® Fungicide to completely disperse. Spray the mixture with the agitator running.

Ground Application: For tree crops, apply in a minimum of 50 gallons of water per acre unless specified otherwise. For other crops, apply in a minimum of 10 gallons of water per acre unless specified otherwise.

Aerial Application: For tree crops, apply in a minimum of 10 gallons of water/A unless specified otherwise. For other crops, apply in a minimum of 2 gallons of water per acre unless specified otherwise.

Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. Do not apply this product through any other type of irrigation system. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts. #### **Operating Instructions**

- The system must contain a functional check-valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water-source contamination from backflow.
- The pesticide injection pipeline must contain a functional, automatic, quick-closing check-valve to prevent the flow of fluid back toward the injection pump.

- Determine the size of the area to be treated.
- Determine the time required to apply ½ -½ inch of water over the area to be treated when the system and injection equipment are operated at normal
  pressures as recommended by the equipment manufacturer. When applying Topaz<sup>®</sup> Fungicide through irrigation equipment use the lowest obtainable
  water volume while maintaining uniform distribution. Run the system at 80-95% of the manufacturer's rated capacity.
- Using water, determine the injection pump output when operated at normal line pressure.
- Determine the amount of Topaz<sup>®</sup> Fungicide required to treat the area covered by the irrigation system.
- Add the required amount of Topaz<sup>®</sup> Fungicide and sufficient water to meet the injection time requirements to the solution tank.
- Make sure the system is fully charged with water before starting injection of the Topaz<sup>®</sup> Fungicide solution. Time the injection to last at least as long as it takes to bring the system to full pressure.
- Maintain constant solution tank agitation during the injection period.
- Continue to operate the system until the Topaz<sup>®</sup> Fungicide solution has cleared the sprinkler head.

#### Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

- Determine the acreage covered by the sprinklers.

Topaz<sup>®</sup> Fungicide is a systemic fungicide for use on turfgrasses for the control of dollar spot (*Sclerotinia homeocarpa*), brown patch (*Rhizoctonia solani*), anthracnose (*Collectorichum graminicola*), red thread (*Laetisaria fuciformis*), pink patch (*Limonomyces roseipellis*), rust (*Puccinia graminis*), powdery mildew (*Erysiphe graminis*), stripe smut (Ustilago striiformis and Urocystis agropyni), summer patch (*Magnaporthe poae*), necrotic ring spot (*Leptosphaeria korrae*), spring dead spot (*Leptosphaeria korrae*, *Leptosphaeria narmari*, *Ophiosphaerella herpotricha*, *Gaeumannomyces graminis*), take-all patch (*Gaeumannomyces graminis*), telaf spot (*Bipolaris* spp.), gray leaf spot (*Pyricularia grisea*), pink snowmold (*Microdochium nivale*), Fusarium patch (*Fusarium nivale*), squsay snowmold (*Nicrodochium nivale*), Fusarium patch (*Rhizoctonia seolari*).

#### **Turf and Ornamental Restrictions:**

- Do not apply more than 5.4 gallons per acre (16 fl. oz. per 1000 sq. ft.) of Topaz® Fungicide.
- Do not apply more than 1.79 lbs. Propiconazole a.i. of Topaz<sup>®</sup> Fungicide per acre per application
- Do not apply more than a maximum of 7.2 lbs. per year of Topaz<sup>®</sup> Fungicide.

## MIXING INSTRUCTIONS

Fill the spray tank ½ - ¾ full with water. Add the proper amount of Topaz® Fungicide and then add the rest of the water. Provide sufficient agitation during mixing and application to maintain a uniform emulsion.

If Topaz<sup>®</sup> Fungicide is tank mixed with other products, use the following sequence:

- Always check the compatibility of the tank mix using a jar test with proportionate amounts of Topaz<sup>®</sup> Fungicide, other chemicals to be used, and the water, before mixing in the spray tank.
- 2. Provide sufficient jet or mechanical agitation during filling and application to keep the tank mix uniformly suspended.
- 3. Fill tank at least 1/2 full of clean water.
- Add wettable powders to the tank first, allowing them to completely suspend in the tank before proceeding. This process can be hastened by premixing the product in water before adding to the tank.
- 5. Add flowables or suspensions next.

As an additional benefit, Topaz<sup>®</sup> Fungicide will improve the rate of establishment when it is applied to cool season grass seedlings or sod.

New Seedlings: Apply 0.35 fl. oz./1,000 sq. ft. at the 2 to 3-leaf stage of growth for faster root development and top growth.

Sod: Apply 0.35 fl. oz./1,000 sq. ft. 2-6 weeks before cutting for increased sod knitting and faster establishment after laying. Observe a 7 day re-treatment interval between applications.

NOTE: For outdoor uses, you can apply up to 2.0 gallons of Topaz® Fungicide/acre/crop/calendar year.

For general disease control in landscapes, apply 2.2-3.0 fl. oz./100 gals. water every 21 days. For best control, begin Topaz<sup>®</sup> Fungicide applications before disease development.

**Note:** Plant tolerances to Topaz<sup>®</sup> Fungicide have been found acceptable for the specific genera and species of plants listed under the Directions for Use. - Mix 0.75-1.5 fl. oz. of Topaz<sup>®</sup> Fungicide in 100 gals, of water and apply as a full coverage spray to the point of drip. Apply every 14-21 days during the period of primary infection. If disease is present, tank mix with an EPA-registered contact fungicide. For flower blight, apply Topaz<sup>®</sup> Fungicide when there is 5-10% bloom and again at 70-100% bloom. For dogwoods, apply the 0.75-1.5 fl. oz. rate every 14 days, or apply 3 fl. oz. of Topaz<sup>®</sup> Fungicide every 28 days.
